



EXHIBITION REGULATIONS

for the Philatelic Exhibition in Rank 1

„Alpen-Adria 2024“

from 13th to 15th September 2024
in Amberger Congress Centrum (ACC)



1. Organizer, Place, Time

1.1. The stamp exhibition "Alps-Adriatic 2024" will be held from 13 to 15 September 2024 as Tier 1 competition exhibition. The event is organised by the Landesverband Bayerischer Philatelistenvereine e.V.

2. Exhibitors

2.1. The exhibition will take place from 13 to 15 September 2024 at the Amberg Congress Centre (ACC), Schießstätteweg 8, 92224 Amberg. It will be carried out with evaluation in accordance with the Alps-Adriatic Exhibition Regulations and the Exhibition Regulations (AO), the Implementing Regulations (DB) and the Evaluation Regulations (BR) of the BDPH or the DPhJ in the latest version at the time of the registration deadline for exhibitors.

2.2. The exhibits referred to in point 4 and in accordance with the exhibition regulations may be exhibited from a country affiliated to the Alps-Adriatic philately. The prerequisite for participation is the timely registration of the exhibit.

2.3. The presentation of the Exhibitor Pass is mandatory.

2.4. The registration form must be completed in full, i.e. also the short description sheet, which is used by the jury for preparation.

3. Registration and acceptance, number of frames

3.1. The registration of exhibits must be submitted to the Commissioner General by the responsible Commissioner by 1 June 2024 at the latest. Address of the Commissioner General: Thomas Bauer, Curd-Jürgens-Str. 20, 81739 Munich, e-mail bauertho@arcor.de. Registrations are only possible on the organizer's forms in German or English. The registration must be accompanied by a short description and a current copy of the exhibitor's passport of the exhibit.

3.2. 50 frames are reserved for each country.

3.3. A maximum of 7 frames can be assigned to each exhibit. The frame size is 98 x 132 cm (16 sheets).

3.4. The Philatelic Committee decides on the acceptance of the exhibit. With the confirmation of acceptance, the respective commissioner or exhibitor receives notification of the allocated frame number. In the event of rejection of the exhibit, the commissioner or exhibitor will be informed of the reasons. This notification shall be made immediately after the decision of the Philatelic Committee. This decision is final.

3.5. By 15.07.2024, the respective national commissioner shall be notified of the number of allocated frames as well as the number of exhibits accepted. By accepting the exhibit, the exhibitor irrevocably undertakes to participate in the exhibition with this exhibit.

5. Exhibition fees

5.1. The exhibition fee is €25 per frame (16 sheets). Excluded from the frame fee are the youth exhibits. For 1-frame exhibits with 16 sheets, the exhibition fee is also €25. There is also a charge of €25 per literature exhibit. 2 copies must be sent. The exhibitor is also given the opportunity to present his object in one frame suitable for 16 pages DIN A4 (title page, table of contents and 14 exemplary pages).

5.2. The exhibition fees must be paid into the Organizer's account within 14 days of receipt of the confirmation of acceptance and invoice. IBAN and BIC will be provided with the confirmation of acceptance.

5.3. In exceptional cases, the exhibition fees may be paid in cash immediately prior to the mounting of the exhibit. However, this is only possible after prior written consultation with the exhibition manager.

6. Security and insurance

6.1. The Organizer shall take the greatest possible care in the handling and safety of the exhibits in the exhibition rooms. Liability for damage, loss or other losses is not assumed, with the exception of intentional or grossly negligent actions of the organizer and its employees.

6.2. Each exhibitor is strongly advised to take out their own insurance for transport and exhibition.

7. Mounting and dismantling of the exhibits

7.1. If possible, the exhibits should be mounted by the commissioner or exhibitor or a person commissioned by him (with written power of attorney) on Thursday 12.09.2024 from 12 noon to 5 p.m.

7.2. If it is not possible for the commissioner or exhibitor or a representative to set it up, the exhibit must be sent to the address given in the confirmation of acceptance by 05.9.2024 at the latest.

7.3. The exhibits are to be sent to the Organizer free of charge and with a prepaid delivery fee by postal parcel.

7.4. It is not possible to deposit parts of the collection.

7.5. Each exhibition sheet must be individually housed in a sturdy transparent cover.

7.6. The exhibition sheets are inserted horizontally into the frame from left to right.

7.7. The dismantling will take place on 15.09.2024 after the exhibition closes at 1 p.m. No exceptions will be made.

7.8. Exhibits that are not dismantled by the exhibitor or a representative of the exhibitor will be dismantled by the exhibition management after the exhibition has closed, packed and returned to the exhibitor's address at the exhibitor's expense. For this purpose, prepared packaging material, prepared address label and parcel card, as well as the required postage must be attached. The return is made as a postal parcel at the risk of the recipient. Certificate, jury's report, exhibitor passport and, if applicable, honorary prize will be attached to the shipment if possible.

8. Evaluation of the exhibits

8.1. The exhibits will be judged by a jury in accordance with the Alps-Adriatic Exhibition Regulations and the provisions of the Exhibition Regulations and the Evaluation Regulations of the BDPh, or, in the case of the Youth, according to those of the DPhJ.

8.2. The jury may consult expert advisors from the BDPh working groups or specialists known to it.

8.3. The evaluation forms of the BDPH/DPhJ are used for evaluation. Each exhibitor will receive a copy of their evaluation form with the score determined by the jury. After the publication of the jury's report, awards and evaluations will be attached to each exhibit.

8.4. On Thursday, 13.09.2024 between 3 and 6 p.m., discussions between exhibitors and jurors will take place before the exhibition. The time in which the exhibitor can present his exhibit to the respective team of jurors depends on the pre-registrations. Please tick yes or no on the registration form under "Jury preliminary discussion".

8.5. The announcement of the jury's report and the presentation of the awards are scheduled for Saturday, 14.09.2024 as part of the festive evening.

8.6. On Sunday, 15.09.2024, from 10.00 a.m. to 1.00 p.m., the jurors will be available to advise the exhibitors at the exhibits.

8.7. The composition of the jury will be announced in the exhibition catalogue.

9. Awarding of awards

9.1. The diplomas provided for in the exhibition regulations and the evaluation regulations of the BDPH/DPhJ will be awarded.

10. Rights of the exhibition management

10.1. The exhibition management has the right, in particular with regard to the aim of the exhibition, the suitability of the registered exhibits and the numerical number of registrations received earlier, to reject exhibits that have already been registered or already sent in in whole or in part, after consultation with the Philatelic Committee, or to bring them to the exhibition in a form other than the type of application.

10.2. In any case, the exhibition fee must be paid for exhibits that are not sent in time.

10.3. In all cases not provided for in these Terms and Conditions, the Exhibition Management shall decide.

11. General Provisions

11.1. By signing the registration form, the exhibitor expressly acknowledges these terms and conditions of the exhibition as well as the exhibition regulations of the BDPH, which can be sent to him by the Federal Office of the BDPH (for a fee for postage).

11.2. During the event, the exhibition and event management exercises domiciliary rights within the exhibition rooms.
